## **2.Chair's Report**

### **Membership**

- We are delighted to say that in this our ninth year we now have over 1, 000 members! This is an enormous achievement, and we are particularly pleased with a net increase of nearly 25% on our numbers this time last year.
- We're delighted that **Grant Robbins** is here today to collect his reward for being the 1,000<sup>th</sup> member
- **Julia Simpson** and **Peter Dennis** also qualify for champagne, being members 998 and 999 and **Garrick Collier** is the existing Quinssa member who qualifies for nominating one of the lucky new members,
- Thanks are due to all the committee members and, in particular, to Scott for managing the membership database so effectively.
- We believe that our growth continues because we continue to offer increasing **membership benefits**, either through our own resources, through our sponsors or with the help of the Club, for which we are grateful.
- We are, as always, grateful to our membership in supporting our various fund raising activities.
- Despite organising (and subsidising) more activities, we have been able to keep our membership fees at the same £5 per year level since Quinssa was formed.

### **Events**

We have run quite a few events in the 2011/12 year, including:

- The "Meet the ... evenings with:

- the ever ambitious Conor;
- the irrepressible Davids Ellis & Morgan;
- the down to earth John Kingston, the coaching team and Ed Spokes
- and finally - with Wayne Barnes and his gorilla!
- We also had our first ever Quinssa Summer Ball. Thanks to Emma for organising it and to the Players for giving up their time to be there.
- Thanks to divine intervention from Gareth Harkin, we were again able to organise special reduced price tables for Quinssa members at the Players' Awards Dinner.
- For the immediate future, we have
  - the Quinssa Summer Party, this year at the Lensbury, in a few days' time - with over 100 people going
  - our second Quinssa Summer Ball coming up on July 20<sup>th</sup>, again with Players attending
- If you haven't got your tickets yet, now's the time! Both of these events are subsidised for Quinssa members

### **Fund raising**

- We have raised funds at some of our events for the Quins chosen charity, this year, Right to Play, but, as normal, our main fundraising thrust has been for the Quins Academy.
- Once again we raised significant sums for the Academy and presented Tony Diprose with a cheque for £3,370.55 at the Premiership semi-final.
- This really does enable some of the academy players to gain rugby experience outside of the normal Academy structure which they would not otherwise have been able to do. This year, for example, we have sent Sam Stuart to Nick Evans' old club, East Coast Bays, in North Harbour. As well as being a fantastic experience for Sam the opportunity to play a club season in a demanding environment is just what he needs. Having missed so much of the last two seasons it gives him a great opportunity to get back up to form so that he hits the ground running for Quins next season.

### **Coaches & overseas matches**

- We ran coaches & bought "block booking" tickets to nearly all the away matches, where practical. Coaches were better used this year and we managed effectively to wipe out last year's small losses, so the coaches account is more or less in balance.
- Foreign travel included Toulouse, Toulon and our traditional cold wet windy weekend in Galway!

### **The Survey**

- For the first time this year, we decided to run a fairly extensive survey of our members and received a LOT of feedback – about 1/3 of our membership at the time responded. Emma has the details: .....

### 3.Treasurer's Report

Treasurer's Report on the financial year to 30<sup>th</sup> April 2012.

Firstly I would like to thank our member David Holland for once again auditing and approving the accounts. We are very appreciative of his work on our behalf.

I'm sure that all of you have scrutinised the accounts over the last few days and have loads of questions for me later, but hopefully not!

This has been the second year for me as treasurer and the simple changes I introduced in the first year have made it easier to manage the Association's finances. At this time last year membership was approaching 800 and now we are on the brink of having 1000 members which brings its own issues in respect of controlling the income and expenditure. However with the support of my fellow committee members and particularly Scott Cooke, our Membership Secretary, it has been a straightforward and enjoyable task for me.

The funds available to the committee to run the association are healthy and the finances in good order. Most of the club's sponsors continue to be supportive and with your input at our events we are able to make considerable donations to charity and to the Academy. We presented a cheque for £3370.55 to the Academy at the last home game of the season.

The association has continued to provide coaches to away games where feasible and they required a small subsidy to operate over the financial year which does not exactly match the season. I believe we should continue to provide this service and to subsidise to a reasonable extent if necessary.
